

ALCONA TOWNSHIP BOARD MINUTES

June 09, 2020

The Alcona Township regular board meeting was called to order with the Pledge of Allegiance to the flag.

Roll call: Present: Supervisor Marlena MacNeill, Clerk Dawn LaLonde, Treasurer Tina Gauthier and Trustees Jim Bouchard and Jim Mead.

Motion by Mead, seconded by Bouchard to approve the minutes from the previous meeting. Passed All in Favor.

Motion by Mead, seconded by LaLonde, to accept the treasurer's report as presented. PASSED All in Favor.

Motion by Mead, seconded by Bouchard, to pay bills as presented.

Motion by LaLonde, seconded by Mead, to pay the MTA annual dues at a cost of \$1771.23. PASSED All in Favor.

A question concerning one person owning property in Scotts Park Special Assessment and also being a 1/3 owner of another parcel whether he should be subject to paying again. The board reviewed the contract and agreed the language does not exclude him from paying on the second parcel.

The DNR will dredge the river again this year. Supervisor MacNeill will contact DeRocher Masonry concerning the sand pile from 2019 dredging.

Dan Gauthier along with LeeRoy LaLonde will work on a gang plank extension.

Fire Report was received.

Zoning Administrator, Tammy Mendyka, reported that she has been busy writing Land Use Permits and is also handling some nuisance complaints. She had contacted Attorney Wilson concerning a zoning violation and now that the Covid-19 restrictions have been lifted she will touch base with him again to see if he was able to follow up with the issue.

Motion by Gauthier, seconded by Mead, to approve three road agreements contingent on exploring the cost of black top overlay on Hubbard Lake and Black River Road. PASSED All in Favor.

Agreement AL2001 Mt Maria Rd. from Caledonia Twp. Line S. to Hawes Twp. Line seal coat with fog seal \$67,857.00

Agreement AL2002 LaFave Rd. single seal coat \$8,577.00

Agreement AL2003 Black River Road from US 23- Lake Shore Dr. seal coat with fog seal \$98,302.00

Motion by LaLonde, seconded by Gauthier, to approve fireworks permit for The Hardwoods on July 3, 2020, contingent upon them providing proof of insurance. PASSED All in Favor.

Motion by Gauthier, seconded by Bouchard, to approve Lost Lake Woods Club fireworks permit for July 4, 2020. PASSED All in Favor.

County Commissioner, Dan Gauthier, reported that the court house is now open and the library will be opening shortly.
